AN ORDINANCE BY AND OF THE COUNCIL OF THE BOROUGH OF
WEST MAYFIELD, BEAVER COUNTY, PENNSYLVANIA, ESTABLISHING
MONTHLY COMPENSATION FOR WEST MAYFIELD BOROUGH COUNCILMEN
PERSONS AND THE MAYOR AFTER THE EFFECTIVE DATE OF SAID
ORDINANCE.

WHEREAS, the General Assembly of the Commonwealth of Pennsylvania has enacted P.L. 581, February 1, 1966, as amended, setting forth certain guidelines and limitations for the compensation of Council Members and the Mayor; and

WHEREAS, said Act provides that Borough Council Members in Boroughs having a population of not more than 4,999 may be compensated in an amount not to exceed \$1,875.00 per year; and

WHEREAS, said Act provides that Mayors in Boroughs having a population of not more than 4,999 may be compensated in an amount not to exceed \$2,500.00 per year; and

WHEREAS, the population of West Mayfield Borough is less than 4,999; and

BOX 437 2400 DARLINGTON FIOAD BEAVER FALLS, PA 15010 [412] 846-7171 WHEREAS, the General Assembly by said Act authorizes the Borough Council of various Boroughs to determine the compensation of Council Members and the Mayor subject to limitations set forth in the Act.

NOW, THEREFORE, it is hereby enacted and ordained as follows:

- 1. Each Council person elected or appointed to office on or after the effective date of this Ordinance shall receive compensation for attending duly advertised general or special public meetings or hearings of the Borough Council, or other meetings authorized by the Borough Council at the rate of \$100.00 for each meeting attended by such Council person, not to exceed \$1,200.00 per year.
- 2. Any Mayor elected or appointed to office on or after the effective date of this Ordinance shall receive compensation for attending duly advertised general or special public meetings or hearings of the Borough Council, or other meetings authorized by the Borough Council at the rate of \$100.00 for each such meeting attended by such Mayor, not to exceed \$1,200.00 per year.
- 3. Such compensation shall be paid in equal monthly installments of \$100.00 per month.

This Ordinance shall be effective at the time approved by Borough Council and authorized by the Mayor.
