210.01 DESIGNATION; CITATION; HEADINGS.

(a) All ordinances of a general and permanent nature of the Borough, as revised, codified, rearranged, renumbered and consolidated into component codes, titles, chapters and sections, shall be known and designated as the Codified Ordinances of West Mayfield, Pennsylvania, 1976, for which designation "Codified Ordinances" may be substituted.

Code, title, chapter and section headings do not constitute any part of the law as contained in the Codified Ordinances.

(b) All references to codes, titles, chapters and sections are to such components of the Codified Ordinances unless otherwise specified. Any component code may be referred to and cited by its name, such as the "Traffic Code." Sections may be referred to and cited by the designation "section" followed by the number, such as "Section 210.01."

210.02 AMENDMENTS AND SUPPLEMENTS; NUMBERING.

(a) The Codified Ordinances of West Mayfield, Pennsylvania, 1976, may be amended or supplemented at any time and, when any amendment or supplement is adopted in such form as to indicate the intention of Council to make the same a part thereof, such amendment or supplement shall be incorporated in, and deemed a part of, the Codified Ordinances, so that a reference to the Codified Ordinances shall be understood and construed as including the Codified Ordinances of West Mayfield, Pennsylvania, 1976, and any and all such amendments and supplements.

(b) All amendments and supplements enacted as a part of the Codified Ordinances shall be integrated therewith by following the form of arrangement and plan set forth in the original Codified Ordinances as follows: each Code shall be subdivided into titles; each title shall be subdivided into chapters, and each chapter shall be subdivided into sections, which shall be numbered in accordance with the decimal numbering system. The numbering of all sections, except penalty sections, shall be consecutive within each chapter commencing with the first section of Chapter 210, which shall be numbered 210.01, the first "2" signifying Code 2, and the two figures "10" before the decimal signifying the chapter within the Code, and the two figures "01" after the decimal signifying the first section in Chapter 210 of the Code. Penalty sections shall be designated "99" and shall be the last section of a chapter.

210.03 DEFINITIONS AND INTERPRETATION.

In the construction of the Codified Ordinances, the following rules and definitions shall control, excepting those inconsistent with the manifest intent of Council as disclosed in a particular provision, section or chapter:

- (a) Adopting Ordinance. "Adopting Ordinance" means the ordinance of the Borough adopting the Codified Ordinances of West Mayfield, Pennsylvania, 1976, in conformity with the Borough Code of Pennsylvania and this Chapter 210.
- (b) Authority. Whenever in the Codified Ordinances authority is given to an officer or an act is required to be performed, such authority may be exercised and such act may be performed, at the instance of such officer, by a deputy or subordinate, unless contrary to law or to the clear intent of any such particular provision.
- (c) Borough and Municipality. "Borough" and "Municipality" mean the Borough of West Mayfield, Pennsylvania.
- (d) Borough Code. "Borough Code" means Act of the General Assembly No. 581, passed February 1, 1966, (P.L. 1656), as amended.

- (e) Calendar-Computation of Time. The terms "month" and "year" mean the calendar month or year. The time expressed in days within which an act is to be done or a period is to expire shall be computed by excluding the first and including the last day, unless the last day is a Sunday, in which case it shall be excluded. If time is expressed in hours, the whole of Sunday shall be excluded.
- (f) Conjunctions. "And" includes "or" and "or" includes "and," if the sense so requires.
- (g) Council. "Council" means the Council of the Borough of West Mayfield, Pennsylvania.
- (h) County. "County" means the County of Beaver, Pennsylvania.
- (i) Gender. Words importing the masculine shall extend and be applied to the feminine and neuter genders.
- (j) General Rule. Except as otherwise provided in this section, words and phrases shall be construed according to the common usage of the language, provided, however, that technical words and phrases and such others as may have acquired a special meaning in the law shall be construed according to such technical or special meaning.
- (k) Joint Authority. Words giving authority to a board, commission, authority or to three or more officers or employees or other persons shall be construed as giving authority to a majority thereof, unless otherwise specifically provided.
- (l) Keeper and Proprietor. "Keeper" and "proprietor" mean persons, firms, associations, corporations, clubs and copartnerships, whether acting by themselves or as a servant, agent or employee.
- (m) Land and Real Estate. "Land" and "real estate" include rights and easements of an incorporeal nature.
- (n) Number. Words in the plural include the singular and words in the singular include the plural number.
- (o) Oath. "Oath" includes affirmation. When an oath is required or authorized by law, an affirmation in lieu thereof may be taken by a person having conscientious scruples about taking an oath. An affirmation shall have the same force and effect as an oath.
- (p) Owner. "Owner," when applied to property, includes a part owner, joint owner or tenant in common of the whole or any part of such property.
- (q) Person. "Person" means an individual, association, club, corporation, firm, partnership or body politic.
- (r) Premises. "Premises," when used as applicable to property, extends to and includes land and buildings.
- (s) Property. "Property" includes real and personal property and any mixed and lesser estates or interests therein. "Personal property" includes every kind of property except real property; "real property" includes lands, tenements and hereditaments.
- (t) Reasonable Time. In all cases where provision is made for an act to be done or notice to be given within a reasonable time, it shall be deemed to mean such time only as may be necessary for the prompt performance of such act or the giving of such notice.

- (u) Sidewalk. "Sidewalk" means any portion of a street between the curb line and the adjacent property line, intended for the use of pedestrians, excluding parkways.
- (v) State and Commonwealth. "State" and "Commonwealth" mean the Commonwealth of Pennsylvania.
- (w) Street. "Street" means alleys, avenues, boulevards, lanes, roads, streets, State highways and other public ways in the Borough.
- (x) Tenant and Occupant. "Tenant" and "occupant," as applied to buildings or land, shall extend and be applied to any person holding a written or oral lease of, or who occupies the whole or any part of, a building or land, alone or with others.
- (y) Tenses. The use of any verb in the present tense includes the future.
- (z) Time. Whenever any time established in the Codified Ordinances for the taking of any action expires on a Sunday or legal holiday, such time shall not expire on such day but shall expire on the next week day.

210.04 SEPARABILITY OF PROVISIONS.

Each section and each part of each section of the Codified Ordinances is hereby declared to be an independent section or part of a section and notwithstanding any other evidence of legislative intent, it is hereby declared to be the controlling legislative intent that if any such section or part of a section, or any provision thereof, or the application thereof to any person or circumstance, is held to be invalid, the remaining sections or parts of sections and the application of such provision to any other person or circumstance, other than those as to which it is held invalid, shall not be affected thereby, and it is hereby declared to be the legislative intent that the Codified Ordinances would have been adopted independently of such section or part of a section so held to be invalid.

210.05 SECTIONS AND ORDINANCES REPEALED.

All ordinances and parts of ordinances in conflict with the provisions of the Codified Ordinances of West Mayfield, Pennsylvania, 1976, are hereby repealed.

210.06 EXEMPTIONS FROM REPEAL.

The repeal provided for in Section 210.05 shall not affect:

- (a) Any offense or act committed or done, or any penalty or forfeiture incurred, or any contract or right established or accruing, before the adoption of these Codified Ordinances;
- (b) Any ordinance or resolution promising or guaranteeing the payment of money by or to the Borough, or authorizing the issuance of any bonds of the Borough, or any evidence of the Borough's indebtedness, or any contract or obligation assumed by the Borough;
- (c) The administrative ordinances and resolutions of Council not in conflict or inconsistent with the provisions of the Codified Ordinances;
- (d) Any right, license or franchise conferred by any ordinance or resolution of Council on any person or corporation;
- (e) Any ordinance establishing, naming, relocating or vacating any street or other public way;
- (f) Any ordinance or part thereof providing for the establishment of positions, for salaries or compensation;

- (g) Any prosecution, suit or other proceeding pending, or any judgment rendered, on or prior to the adoption of these Codified Ordinances;
- (h) Any ordinance levying or imposing taxes or assessments;
- (i) Any ordinance establishing or changing the boundaries of the Borough; or
- (j) Any ordinance or resolution adopted by Council after the adoption of the Codified Ordinances.

210.99 GENERAL CODE PENALTY.

Whoever violates or fails to comply with any of the provisions of these Codified Ordinances, for which no penalty is otherwise provided, shall be fined not more than three hundred dollars (\$300.00) or imprisoned not more than thirty days, or both. A separate offense shall be deemed committed each day during or on which a violation or noncompliance occurs or continues.

The Borough shall annually appoint an Independent Auditor, under authority of Section 1005 of the Borough Code. The Independent Auditor shall be either a certified public accountant, registered in the State, a firm of certified public accountants, so registered, a competent public accountant or a competent firm of public accountants. The Independent Auditor shall make an independent examination of the accounting records of the Borough for the fiscal year and perform such other duties and exercise such powers as are conferred upon him by the statutes of the Commonwealth.

248.01 DUTIES OF FIREMEN; WORKMEN'S COMPENSATION.

Volunteer firemen shall have the duties outlined in this section. For the purpose of the Workmen's Compensation Act, such firemen shall be considered to be in the employ of the Borough and acting in the course of their employment if and when they are assisting or doing any of the following acts:

- (a) Going to or returning from a fire or fire alarm either within or outside the Borough;
- (b) Performing rescue work, either of persons, animals or property, whether connected with fires, floods or other unusual circumstances;
- (c) Performing acts of mercy or assistance in a conflagration, epidemic, fire, bombing, wreck, accident or any other unusual occurrence where public policy would require services in addition to those now in existence or services not provided for by the Borough at the present time;
- (d) Performing those incidental duties usually performed by fire or police personnel when requested through proper channels by a taxpayer, excluding those set forth in subsections (a), (b) and (c) hereof, but including participation in exhibitions and the display of fire prevention techniques and equipment either within or outside the Borough; or
- (e) Performing police duties of any kind, including traffic control, detection, protection and keeping of order. (Ord. 92. Passed 6-1-42.)

252.01 PAYROLL DEDUCTIONS FOR SOCIAL SECURITY.

(a) The Social Security System is hereby extended to full-time employees of the Borough in order that such employees may participate in the provisions of the Old Age and Survivors Insurance System.

(b) The Borough is hereby authorized to execute and deliver to the Secretary of Labor and Industry of the Commonwealth, hereinafter referred to as the "State Agency," a plan or plans and agreement, as required under Section 6 of the Social Security Act (Act No. 491 of 1951, as amended), to extend coverage to employees of the Borough and to do everything necessary to effectuate coverage of such employees under the Old Age and Survivors Insurance System.

(c) The Borough Secretary-Treasurer is hereby authorized to establish a system of payroll deductions to be matched by payments by the Borough to be made into the Contribution Fund of the Social Security Act through the office of the State Agency, and to make charges of such tax to the fund out of which the wages or salaries are paid to such employees. Payments shall be made in accordance with the provisions set forth by the State Agency and the Secretary of Health, Education and Welfare.

(d) Appropriation is hereby made from the proper fund of the Borough in the amount necessary to be paid into the Contribution Fund, as provided in Section 4 of the Enabling Act and in accordance with the plan or plans and agreement referred to in subsection (b) hereof.

(e) Authority is hereby given to the Mayor and the Borough Secretary-Treasurer to enter into an agreement with the State Agency, which agreement shall be in accordance with paragraph 218 of the Social Security Act and which agreement shall provide that participation shall commence as of October 1, 1954.
